Subject: Jadui Pitara' - a play-based learning-teaching material tailored for children between the age group of 3-8 years and Guidelines for Balvatikas (Pre-primary Education).

As part of the government's commitment to enhancing the educational experience and ensuring a child-centric, vibrant, and enjoyable learning environment, Jaadui Pitara (JP) was introduced on February 20, 2023. Aligned with the National Curriculum Framework for the Foundational Stage (NCF-FS) 2022, JP is a play-based teaching and learning resource designed to cater to the diverse needs of foundational learners.

JP focuses on fostering development in five crucial domains: physical, socio-emotional and ethical, cognitive, language and literacy, and aesthetic and cultural. This comprehensive collection, serving as an exemplary resource for Foundational Stage schools, includes toys, games, puzzles, puppets, posters, flashcards, story cards, student playbooks, and teacher handbooks. With content available in 13 languages, JP is tailored to resonate with local cultures, promoting curiosity and enriching the educational experience.

This initiative represents a significant stride towards aligning educational content with children's perspectives, in line with the vision outlined in the National Education Policy (NEP) 2020. JP, while supporting pedagogy to achieve a broad range of NCF-FS Curricular Goals, acknowledges the need for additional content and pedagogical strategies to fulfil all Learning Outcomes and Competencies. Schools are encouraged to develop similar set of materials for the Foundational Stage in line with the National Curriculum Framework and Syllabus for the Foundational Stage for ensuring all the stipulated learning outcomes and competencies.

A digital version of Jadui Pitara or e-Jaadui Pitara (e-JP) is also available in the form of an app. It is initially developed for Android users along with browser access at <https://ejaaduijitara.ncert.gov.in/>. In due course of time, e-JP shall be available for iOS users also. The app currently has more than 1,000 stories in different languages. Using Artificial Intelligence, it comprises of three bots, viz.

- Katha Sakhi: Your storyteller Buddy, bringing magical tales to life;
- Teacher Tara: A guide for educators, offering tips and resources; and
- Parent Tara: A supportive companion for parents, providing guidance and fun activities.

e-JP is an app initially developed for Android users along with browser access at <https://ejaaduijitara.ncert.gov.in>. In due course of time, e-JP shall be available for iOS users also. e-JP's IVRS interface is also available on Toll free no. 18002120173 /15108 which can be used with the old mobile phones with press-button based inputs, thus, eliminating the requirement of a computer or a smartphone.

CBSE-affiliated schools with Balvatikas (Early Childhood Education sections) or the ones planning to establish it, are advised to create dedicated spaces for Early Childhood Care and Education (ECCE), incorporating an appealing and age-appropriate environment, and incorporating the use of Jaadui Pitara. The extensive use of branding with the NIPUN and Jaadui Pitara logos is recommended to enhance visibility and recognition.

Schools are also directed to consult the Guidelines for Pre-School Education developed by NCERT, available at <https://ncert.nic.in/dee/pdf/guidelines-for-preschool.pdf>, when establishing or modifying existing Balvatikas. This resource provides valuable insights for ensuring the effective implementation of early childhood education practices.
